Dragon Tag or Crossfire Preparer – Which Product?

Rivet's Dragon Tag and Crossfire Preparer products both create XBRL Instance Documents. Although the end result of the two products is the same, the process is very different. Crossfire Preparer hides XBRL terminology from the user and is designed for non-technical users. Dragon Tag is recommended for XBRL-savvy users who want to quickly mark up a few documents or for users who wish to gain a greater understanding of XBRL terminology and theory.
